

# VKB KONQA END USER LICENSE AGREEMENT

## NOTICE TO THE USER. PLEASE READ CAREFULLY.

This is an End User License Agreement “EULA” and otherwise a legal Contract between you, the End User, (either an individual or an entity), and Victor Bagu.

Upon your acceptance of this EULA and upon your payment of the license fee (*or unless otherwise offered as “Free”*), and by downloading and/or installing Victor Bagu Products (“Software”), you will agree to the terms and conditions hereof. As used herein, “Font Software” shall mean coded and encrypted Software that generates typefaces and other designs when used with the appropriate hardware and other software.

You acknowledge that the Software is the intellectual property of Victor Bagu and/or his licensors. “**FREE software**” or a FREE use license does not mean that the Software is “shareware” or “freeware”. Any such FREE Software provided by Victor Bagu and/or his distributors is subject to all the terms and conditions set forth in this EULA.

If you are receiving this software otherwise, and you do not agree to the terms and conditions of this license, please indicate your disagreement by deleting or otherwise removing this software from your possession. Any use or distribution of this software in any way will be hereby strictly prohibited.

“End User” means a retail customer who has purchased a license to use the product rather than for distribution or resale. An End User is not defined as a distributor, reseller, dealer, sub licensee, original equipment manufacturer (“OEM”), or other wholesale buyer, etc. If you are NOT an End user and you wish to distribute or resell the use of Victor Bagu Products, you must notify Victor Bagu to purchase a reseller’s license for which an additional fee may be charged.

Victor Bagu grants to you a non-exclusive, non-transferable license to use the Software provided that you unconditionally agree to the following:

### **Use of the Software/Initial User License**

**1.** The Software must be installed and used at a single Geographic Location for use on up to five (5) computers and/or one (1) output device (“Licensed Units”).

**2.** If the number of Licensed Units with which you want to use the Software exceed those set forth above, or you need to upgrade the number of Licensed Units

with which you have already purchased that are in addition to the Initial User License set forth above, you must notify Victor Bagu or your Victor Bagu distributor to purchase such additional license for which an additional fee may be charged. If you need to use the Software at additional Geographic Locations, you must notify Victor Bagu or your Victor Bagu distributor to purchase an additional Location or Site License for which an additional fee may be charged. You may make one back-up copy of the Software for archival purposes only, and you shall retain exclusive custody and control over such copy. You may also install the Software on one home or portable computer. The license granted herein is effective until terminated. Victor Bagu has the right to terminate your license immediately if you fail to comply with any term of this Agreement. Upon termination, you must destroy or delete the original and any copies of the Software and Documentation.

**3.** You may take a digitized copy of the Software used for a particular document to a commercial printer or service bureau for use by the printer or service bureau in reproducing such document but only if the printer or service bureau represents to you that it has purchased or has been granted a license to use that particular software.

You may not distribute the Font Software to third parties, e.g. on the Internet, CD-ROM etc. If you intend to use the Software in such cases you must request and receive from Victor Bagu or your local distributor a License Agreement for which an additional fee may be charged.

You may electronically distribute Font Software embedded in a “Personal or Internal Business Use” document (that is, a document other than a “Digital Commercial Product” as defined herein) only when the Font Software embedded in such document (i) is in a static graphic image (for example, a “gif”) or an embedded electronic document, and (ii) is distributed in a secure format that permits only the viewing and printing (and not the editing, altering, enhancing, or modifying) of such static graphic image or embedded document. You may not embed the Font Software in any Digital Commercial Product without purchasing an extended license from Victor Bagu authorizing you to do so.

**4.** You agree that the Software, and all copies thereof, are owned by Victor Bagu and/or its suppliers, and

its structure, organization and code are the valuable trade secrets of Victor Bagu and/or its suppliers. You acknowledge that the Software is protected under Zimbabwe trademark and/or Copyright Law, by the trademark and/or copyright and design laws of other nations, and by international treaties.

You agree to treat the Software as you would any other copyrighted material, such as a book. You may not copy or distribute the Software or Documentation, except as expressly provided herein. Any copies that you are permitted to make pursuant to this Agreement must contain the same copyright, trademark, and other proprietary notices that appear on or in the Software. You agree not to modify, adapt, translate, reverse engineer, decompile, disassemble, alter, or otherwise attempt to discover the source code of the Software.

The use of any trademark as herein authorized does not give you any rights of ownership in that trademark and all use of any trademark shall inure to the sole benefit of the trademark owner. Except as expressly provided herein, this Agreement does not grant you any right to intellectual property rights in the Software and its associated trademarks.

5. You may not rent, lease, sublicense, give, lend, or further distribute the Software or Documentation, or any copy thereof, except as expressly provided herein. You may transfer all your rights to use the Software and Documentation to another person or legal entity provided that (i) the transferee accepts and agrees to be bound by all the terms and conditions of this Agreement, and (ii) you destroy all copies of the Software and Documentation, including all copies stored in the memory of a hardware device. Without limiting the generality of the foregoing, you agree that you will not distribute or disseminate all or any part of the Software through any on-line service and you further agree that any such intentional distribution shall constitute a theft by you of a valuable property of Victor Bagu and/or its suppliers.

6. Victor Bagu warrants to you that the Software will perform substantially in accordance with the Documentation for the ninety (90) day period following your receipt of the Software. To make a warranty claim, you must notify the source from which you obtained it along with a copy of your sales receipt within such ninety (90) day period. If the Software does not perform substantially in accordance with the Documentation, the entire and exclusive liability and remedy shall be limited to either, at Victor Bagu's option, the replacement of the Software or the refund of the license fee you paid for the Software. Victor Bagu and his suppliers do not and cannot warrant the performance or results you may obtain by using the software or documentation. The foregoing states the sole and exclusive remedies for

Victor Bagu's or his supplier's breach of warranty. Except for the foregoing limited warranty, Victor Bagu and his suppliers make no warranties express or implied, as to non-infringement of third party rights, merchantability, or fitness for any particular purpose. In no event will Victor Bagu or his suppliers be liable to you for any consequential, incidental or special damages, including any lost profits or lost savings, even if a Victor Bagu representative has been advised of the possibility of such damages, or for any claim by any third party.

Some states of jurisdictions do not allow the exclusions or limitations of incidental, consequential or special damages, so the above exclusion may not apply to you. Also, some countries or jurisdictions do not allow the exclusions of implied warranties or limitations on how long an implied warranty may last, so the above limitations may not apply to you. To the extent permissible, any implied warranties are limited to ninety (90) days. Some jurisdictions do not permit a limitation of implied warranties where the product results in physical injury or death so that such limitations may not apply to you. In those jurisdictions, you agree that Victor Bagu's liability for such physical injury or death shall not exceed One Hundred Thousand Dollars (U.S. \$100,000), provided that such jurisdictions permit a limitation of such liability. This warranty gives you specific legal rights. You may have other rights that vary from country to country or jurisdiction to jurisdiction. The Font Software is non-returnable and nonrefundable.

7. You agree that this Agreement will be governed by the laws of Zimbabwe applicable to contracts wholly performable within such states. Both you and Victor Bagu agree to the personal jurisdiction and venue of these courts in any action related to the Agreement. The Agreement will not be governed by the United Nations Convention of Contracts for the International Sale of Goods, the application of which is expressly excluded. If any part of this Agreement is found void and unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms. You agree that the Software will not be shipped, transferred or exported into any country or used in any manner prohibited by Zimbabwe Export & Import Act or any applicable export laws, restrictions or regulations. This Agreement shall automatically terminate upon failure by you to comply with its terms. This Agreement may only be modified in writing signed by Victor Bagu's authorized officer.
